

#### **EMPLOYMENT AND INCOME CONTRIBUTIONS**

Forest-related economic activity in Harrison County during 2018 generated 794 jobs and over \$120.2 million in income. That's about 0.6% of jobs and 1.9% of income in the county. Employment is the number of full- and part-time jobs in all sectors of the economy. Income includes all forms of employment income, including employee compensation (wages and benefits) and proprietor income, also referred to as labor income.

#### TOTAL OUTPUT AND VALUE ADDED CONTRIBUTIONS

Forestry and the forest products industry generated over \$184.7 million, or about 1.1% of economic output in Harrison County. Forest-related value added amounted to over \$140.6 million, or about 1.5% of all value added in the county. The value of all goods and services produced is defined as total output. Value added is a portion of total output and represents the creation of new wealth.

#### TAX CONTRIBUTIONS

Forest-related economic activity contributed an estimated \$20.64 million in tax revenue for federal, state, and local governments. This represents an estimated tax revenue of \$14.02 million for federal and \$6.62 million for state and local governments.
