### The Economic Contributions of Forestry and Forest Products

# **DeSoto** County

#### **EMPLOYMENT AND INCOME CONTRIBUTIONS**

Forest-related economic activity in DeSoto County during 2018 generated 1,101 jobs and over \$54.0 million in income. That's about 1.2% of jobs and 1.6% of income in the county. Employment is the number of full- and part-time jobs in all sectors of the economy. Income includes all forms of employment income, including employee compensation (wages and benefits) and proprietor income, also referred to as labor income.

#### TOTAL OUTPUT AND VALUE ADDED CONTRIBUTIONS

Forestry and the forest products industry generated over \$256.9 million, or about 2.1% of economic output in DeSoto County. Forest-related value added amounted to over \$85.3 million, or about 1.5% of all value added in the county. The value of all goods and services produced is defined as total output. Value added is a portion of total output and represents the creation of new wealth.

#### TAX CONTRIBUTIONS

Forest-related economic activity contributed an estimated \$17.12 million in tax revenue for federal, state, and local governments. This represents an estimated tax revenue of \$10.52 million for federal and \$6.60 million for state and local governments.

## DESOTO

Forestry and forest products are a major component of DeSoto County's economy. Forest-related economic sectors generate value not only within the forest-related sectors but also in other sectors of the economy. The economic contributions of forest-related sectors and their contributions on other sectors can be estimated using input-output analysis. Using 2018 data, this study estimates the total economic contributions of forestry and the forest products industry to DeSoto County, Mississippi.
